Shop Tip #66 by Jack Dernorsek

Recently I had a small base light bulb that came with a new ceiling fan and the base was so loose that screwing it into the socket would have broken the electrical connection and destroyed the bulb.

I determined that epoxy applied to the bulb to hold the base would not be sufficient because the glass gets too hot and could possibly soften the hardened epoxy. The alternative was to use instant Super type liquid glue, or **cyanoacrylate** but these types harden in small tight spaces but do not fill a void well. I could wick the liquid into the base but the thought of holding the socket firmly made me think that it would get out onto my fingers easily and Super glues stick to skin better than most glues.

A method of thickening cyanoacrylate with baking soda works well to fill voids but the latent moisture in the powder makes for a fast reaction with little working time. So I dipped the bulb base into the soda, trying to force some powder into the interface between the glass bulb and the metal base. After wiping excess baking soda off the base, I dripped a few drops into the edge of the base and in about two seconds, the base was firm and solid.



What is it? A Stits Flut-R-Bug. Hey Rob Rossi, get working on that thing!
